

### **FY19 Funding Issue – Funding for Public Information Liaison**

This request is for 1 Public Information Liaison, grade 19, job code AUN07145 (mid-point).

Currently our office has one FTE (Director Campbell) and one part time employee. The Board of Commissioners are expanding the current amount of events we hold/host annually from 5 to over 12. These events are to be held throughout the entire state and will require more strategic planning and publicity.

Additionally, as we continue to do more community outreach, there is an increase in the volume of requests for the Director to speak and attend various functions and programs. The Commission has also been requested provide information tables at events which also requires staff to be present.

Finally, the commission will be fully engaged in all aspects of digital and social media activities. In order to become an effective and efficient agency, a PIO position is crucial.
